



Long Beach Container Terminal (LBCT) Rules for Truckers

- High Visibility Safety Vest must be worn at all times.
- Speed limit is 10 mph.
- Remember to remove your TWIC from the pedestal.
- Watch for Pedestrians.
- Come to a complete stop at all crossings.
- Yard equipment has the right of way.
- Do not use cellular phone or any electronic devices while driving.
- Obey all posted signs and traffic patterns.
- Wear seat belts when in vehicle.
- No passengers allowed.
- Drive with caution. Make eye contact with other drivers and pedestrians.
- Proceed to your designated destination as prescribed on the in-gate screen. If you forget the block you are supposed to go to, pull into any staging lane to retrieve information.
- Safely back your chassis into an available lane (in your assigned block) that is marked with a green arrow.
- Chassis are not to be resized (sliders) on terminal.
- Ensure chassis size matches container being received/delivered.
- Make sure all chassis pins are in the open position.
- Stand in the booth that is designated for your lane. When the Blue light on your lane appears, you MUST be in the booth for the entire duration of your transaction. If you need assistance, there is a call button in the booth that will connect you for assistance. If you need to stop transaction for an emergency, push e-stop button and take one step outside booth.
- Do not litter, graffiti, defecate, damage the booth. Trash cans and restrooms are available nearby. Please be kind to the next trucker using the booth.
- If you've received a container, ensure all chassis pins are locked prior to driving away.
- Verify container and seal number.
- Trucker must ensure chassis pins are fully unlocked prior to container removal transaction. It is the trucker's responsibility to unlock chassis pins prior to removal of container. Any damage or incident caused from the trucker not unlocking chassis pins prior to the transaction will be the full responsibility of the trucker/ trucking company.
- The opening of container doors is prohibited on terminal. Please proceed to the Flip Line in order to have this done.
- Proceed to and follow designated traffic pattern, do not take short cuts and proceed to Roadability. Drive cautiously through Roadability. Watch for pedestrians.
- If you experience any problems, contact a clerk for trouble resolution.
- If you are involved in an incident, contact Management.
- First Aid kits are available, see Security or Management.
- In case of Emergency, contact Security.
- Follow current CDC guidelines.
- STOP at all STOP signs.
